

# International Registration Application

This registration application should be used when registering a horse based on a certificate of registration issued by an approved international affiliate operating its own studbook ("International Certificate"). Completed forms and questions can be sent to [internationalreg@aqha.org](mailto:internationalreg@aqha.org).

**AQHA WILL ONLY PROCESS INTERNATIONAL REGISTRATION APPLICATIONS THAT ARE RECEIVED FROM APPROVED INTERNATIONAL AFFILIATES. TO REGISTER A HORSE USING THIS APPLICATION, SEND THE FOLLOWING ITEMS TO THE INTERNATIONAL AFFILIATE THAT ISSUED THE INTERNATIONAL CERTIFICATE:**

- Copy of the International Certificate.
- 5 photographs of the horse, consisting of views of the front, back, left side, right side, and a three-quarter view clearly showing the face and all four feet; or, alternatively, submit a drawing of all white markings using the back of this form.
- Completed copy of this application.
- AQHA Registration Fee (\$50 for members with active AQHA memberships; \$115 non-members). Payment must be in U.S. funds. Do not send cash. Check with your international affiliate regarding the way to submit such fee. If applicable and paying by credit card, fill out the credit card information at the back of this application.

**BE ADVISED OF THE FOLLOWING:**

- The horse must trace to a minimum of 93.75 percent (15/16) lineage to horses issued a certificate by AQHA.
- Genetic testing for DNA, parentage verification and health panel may be required pursuant to AQHA rules.
- If a horse is not DNA typed through Veterinary Genetics Laboratory at the University of Davis-California ("UC Davis"), it will be necessary to type the horse through UC Davis if (1) the horse is exported outside of the country in which it was originally registered and is being used for breeding purposes or (2) the horse's semen or embryos are shipped outside of the country in which it was originally registered.
- Subject to certain requirements, AQHA will use the name printed on the International Certificate as the name listed in AQHA's registration records.
